*The Tenderer shall as its answer to R-1 provide the following:*

*The draft Master Milestone Plan shall include what is described in R-1 in Appendix 3, Requirements specification and Appendix 5, Master Milestone Plan.*

*The Tenderer should as its answer to R-1 provide the following:*

- *A draft Detailed Milestone Plan*
- *An example of the Milestone Plan report*

*The draft Detailed Milestone Plan and the example of the Milestone plan report should include what is described in R-1 of Appendix 3, Requirement specification*

### **Sub-appendices**

*The Tenderer shall provide:*

- *The draft Master Milestone Plan in Appendix 5, Master Milestone Plan*

*The Tenderer should provide:*

- *The draft Detailed Milestone Plan in Appendix 5.A, "Detailed Milestone Plan"*

## Requirement R-2

### Authority Approval Plan.

#### **Instruction**

The Tenderer should as its answer to R-5 provide the following:

- An example of the Knowledge sharing summary report specifically headlines and KPI's.

The Tenderer's example of the Knowledge sharing summary report should include what is described in R-5 of Appendix 3, Requirements specification.

## Requirement R-10

### Construction Interface Procedure.

#### **Instruction**

*The Tenderer shall as its answer to R-10 provide the following:*

*The draft Construction Interface Procedure shall include what is described in R-10 of Appendix 3, Requirements specification.*

## Requirement R-11

### Financing Plan.

#### **Instruction**

- *A draft Financing model summary sheet (only to be provided in case of external financing, i.e. not parent company financing)*

*The draft Financing Plan and if relevant, the draft Financing model summary sheet shall include what is described in R-11 of Appendix 3, Requirements specification.*

*The Financing Plan shall be a written description of the input data and cost calculations provided in the excel sheet of the Financing model summary sheet, if relevant.*

*The Financing Plan shall provide a description of the expected investments and funding sources.*

*If the Tenderer has obtained third-party validation, the Tenderer should describe the basis and scope of such validation.*

#### **Sub-appendices**

*The Tenderer should provide:*

- *The draft Financing Plan in sub-appendix 4.O, "Financing Plan"*
- *The draft Financing model summary sheet in sub-appendix 4.P, "Financing model summary sheet"*

## Requirement R-12

### Business Plan.

#### **Instruction**

*The Tenderer shall as its answer to R-12 provide the following:*

- *A draft Business Plan*
- *A draft Business model summary sheet*

*The draft Business Plan and draft Business model summary sheet shall include what is described in R-12 of Appendix 3, Requirements specification.*

*The Tenderer should describe the method for calculation and the validation of the consistency of the data used in the Business Plan with the input data used in the relevant cost calculation sheets in the draft Business model summary sheet.*

*If the Tenderer has obtained third-party validation, the Tenderer should describe the basis and scope of such validation.*

#### **Sub-appendices**

*The Tenderer should provide:*

- *the draft Business Plan in sub-appendix 4.Q, "Business Plan"*
- *The draft Business model summary sheet in sub-appendix 4.R, "Business model summary sheet"*

## Requirement R-13

### Technical Design.

### **Instruction**

The Tenderer shall as its answer to R-13 provide the following:

- A draft Technical Design
- A draft Total design verification plan

The draft Technical Design and draft Total design verification plan shall include what is described in R-13 of Appendix 3, Requirements specification.

### **Sub-appendices**

The Tenderer should provide:

- The draft Technical Design in sub-appendix 4.S, "Technical Design"
- The draft Total design verification plan in sub-appendix 4.T, "Total design verification plan"

## Requirement R-14

Test and Commissioning Plan.

### **Instruction**

The Tenderer shall as its answer to R-14 provide the following:

- A draft Test and Commissioning Plan

The draft Test and Commissioning Plan shall include what is described in R-14 of Appendix 3, Requirements specification.

The Tenderer should as its answer to R-14 provide the following:

- A draft Test event log

The draft Test event log should include what is described in R-14 of Appendix 3, Requirements specification.

- The draft Test and Commissioning Plan in sub-appendix 4.U, "Test and Commissioning Plan"

## Requirement R-18

Report on CO<sub>2</sub> production (subject to the EU ETS)

### **Instruction**

If the CO<sub>2</sub> production is subject to the EU ETS, the Tenderer shall answer R-18, otherwise not.

The Tenderer's shall as its answer to R-18 provide the following:

- An example of the Report on CO<sub>2</sub> production (subject to the EU ETS)

*The example of the Report on CO<sub>2</sub> production (subject to the EU ETS) shall include what is described in R-18 of Appendix 3, Requirements specification.*

*The example of the Report on CO<sub>2</sub> production (subject to the EU ETS) shall include a verified CO<sub>2</sub> emission report (In Danish: CO<sub>2</sub>-udledningsrapport), documenting the actual Fraction of CO<sub>2</sub> production subject to the EU ETS. The verification of the CO<sub>2</sub> emission report shall also be included.*

*The example of the Report on CO<sub>2</sub> production shall also include a forecasted Fraction of CO<sub>2</sub> production (subject to the EU ETS).*

## Requirement R-19

Description of the measurement system for CO<sub>2</sub> storage reporting.

**Instruction**

- *An example of the Report of Delivered Quantity*

*The description of the measurement system for CO<sub>2</sub> storage reporting and the example of the Report on Delivered Quantity shall include what is described in R-19 of Appendix 3, Requirements specification.*

*The description of the measurement system for CO<sub>2</sub> storage reporting should include documentation of any validation and verification of the proposed measurement system for CO<sub>2</sub> storage reporting.*

*The draft CO<sub>2</sub> Origin Verification shall include what is described in R-20 of Appendix 3, Requirements specification.*
