

Fact sheet on the result of the technology neutral tender 2018

The Danish Energy Agency (DEA) called for bids in the technology neutral tender 2018 on 27 September 2018, with a deadline for bids on 26 November 2018. The budget for the tender was DKK 254 million DKK (2018 prices). The DEA has received in total 17 bids with projects of approx. 260 MW onshore wind turbines and approx. 280 MW solar PV installations. It is expected that 6 contracts will be signed, including 3 contracts with approx. 165 MW onshore wind turbines and 3 contracts with approx. 104 MW solar PV installations. This corresponds to approx. 200 MW onshore wind turbines equivalents or the electricity consumption of approx. 160,000 Danish households. The weighted average price premium of the winning bids is 2.28 øre per kWh or approx. 0.31 Eurocent per kWh.

The DEA has sent a conditional award letter to the marginal tenderer. It follows form the conditional award letter that the DEA's award of a price premium contract is conditional upon the marginal tenderer agreeing to downscale the project to a size that can be contained within the remaining budget of almost DKK 8 million. If the Danish Energy Agency does not receive acceptance from the marginal tenderer to downscale the project within the remaining budget, and as there are no other offers with the same price premium as the marginal offer, the remaining budget will not be utilized. The marginal tenderer's deadline expires on 5 December 2018 at 12.00 noon.
